The knowledge and superb teaching methodology, accumulated by professional math teacher and tutor Nadiia Tkachivska during over 30 years, were combined with modern technologies, resulting in developing smartphone application. It contains more than 300 short and concise educational videos and more than 900 tests in Algebra, Geometry and Trigonometry. Every theoretical topic is complemented by practical single and multiple choice tests for those who want to apply freshly-acquired knowledge. All topics are being complemented on the constant basis by new studying materials. Matematikum is an essential tool for learning math.
